## Do Apricots<sup>TM</sup> Work? We Asked the Attorneys!

The poor level of psych reporting in personal injury and workers' compensation evaluations has personally offended me since I started working in those areas in 1985. At that time an orthopedist friend showed me what psych reports were like in an attempt to interest me in the area. On reading those reports I was amazed, shocked and inspired all at the same time and decided that this kind of work was for me. It seemed much more exciting than being a college professor who had been doing research, writing books and teaching classes for 20 years. It also paid a lot better and I had a growing family.

Since I started my practice I have worked on between 5,000 and 10,000 cases and critiqued somewhere in the vicinity of 10,000 to 30,000 psych reports. It's been a lot of fun and now I'm mostly interested in passing on what I've learned and helping attorneys help themselves in this area. That's why there are so many self-help resources on my website, drleckartwetc.com. It's also why I wrote Psychological Evaluations in Litigation: A Practical Guide for Attorneys and Insurance Adjusters, which you can download for free at my website and pass along to whomever you wish. I am very proud to say I have not sold a single copy! It was never for sale.

Since the end of 2013 my monthly newsletters are mostly about Apricots<sup>TM</sup>. An Apricot<sup>TM</sup> describes a psych report's flaws in jargon-free language, discusses specific techniques to Cx the doctor and provides multiple simple questions that get those flaws on the record despite the doctor's resistant

behavior. Apricots<sup>TM</sup> can be written in any medical discipline. When an Apricot<sup>TM</sup> is written in a psych case it can be used in personal injury, workers' compensation, criminal cases, child custody cases or any other litigation where a psych doctor has written a report that the attorney thinks is not credible. Attorneys commission Apricots<sup>TM</sup> when they feel the report lacks depth and quality but as non-experts they don't know where the flaws are and most importantly, they don't know what questions to ask to get those flaws out in the open and on the record when deposing or taking trial testimony from the doctor. Additionally, if discovery has closed, or the attorney chooses not to cross-examine the doctor, an Apricot<sup>TM</sup> can be used to write a brief for the court pointing out all the substantial flaws in a report. Apricots<sup>TM</sup> are work-product privileged reports that are not subject to discovery and can be used in any jurisdiction in the United States or abroad and in asking the court for a remedy. At times I go into court to testify as to the credibility of reports written by the doctors. Of course if there are no flaws found in the doctor's report that information is conveyed to the attorney with no written report and there is no fee for the service or obligation on the attorney's part other than to say "thank you" for the analysis.

Now, to get to the question posed in the title of this newsletter. This past May my wife and I spent a social weekend on the Big Sur coast with a friend from college and his wife. One night at dinner we got to talking about my excitement with the concept of Apricots<sup>TM</sup> and how I was bringing them into practice all around the country.

My friend is retired from a very successful career in marketing so I was dumbfounded when he asked me what my research into the effectiveness of my Apricots TM showed.
